
Limited Warranty

With respect to the remedy of repair or replacement, if identical materials or products are unavailable at the time of repair or replacement, White Knight reserves the right to substitute materials or products of equal or better quality. The remedy provided herein is the sole and exclusive remedy of the reseller.

This warranty does not cover damage to White Knight product that is not caused by a defect in materials or workmanship. Damage not covered by this warranty includes, but is not limited to, damage caused by normal wear and tear, misuse, abuse, improper storage, installation, accidents, improper or inadequate maintenance or cleaning, improper repair or alteration, trauma, fire, water damage, catastrophe or damage caused during transportation or shipping.

Any item repaired or replaced under this limited warranty will be covered by this limited warranty for the remainder of the original one-year warranty period only. This limited warranty shall not be extended as a result of such repair or replacement. The remedies under this warranty do not extend to any person or entity that purchases or rents the item in question from the reseller, but the remedies will remain available to the reseller for the entire warranty period.
